For example: If you placed an order for 3 units of XYZ 12"x12" Patterned paper you would receive a total of 24 individual sheets. An order for 6 units of ABC Embellishments would amount to 18 individual packages.

Payment Options:

A Cherry On Top / Stickers Galore, Inc. accepts all major credit cards including Visa®, MasterCard®, American Express® and Discover®. Net terms are not available at this time. Payment is required at the time the order is submitted.

Return Policy:

A 20% restocking fee is assessed for all pre-authorized returns unless a return is required due to our error. No returns accepted without prior approval. We recommend inspecting your order immediately upon receipt. Any claims for order discrepancies must be received within 10 days of delivery. Claims submitted after 10 days may not be approved. Unauthorized returns are subject to refusal or a 40% restocking fee.
